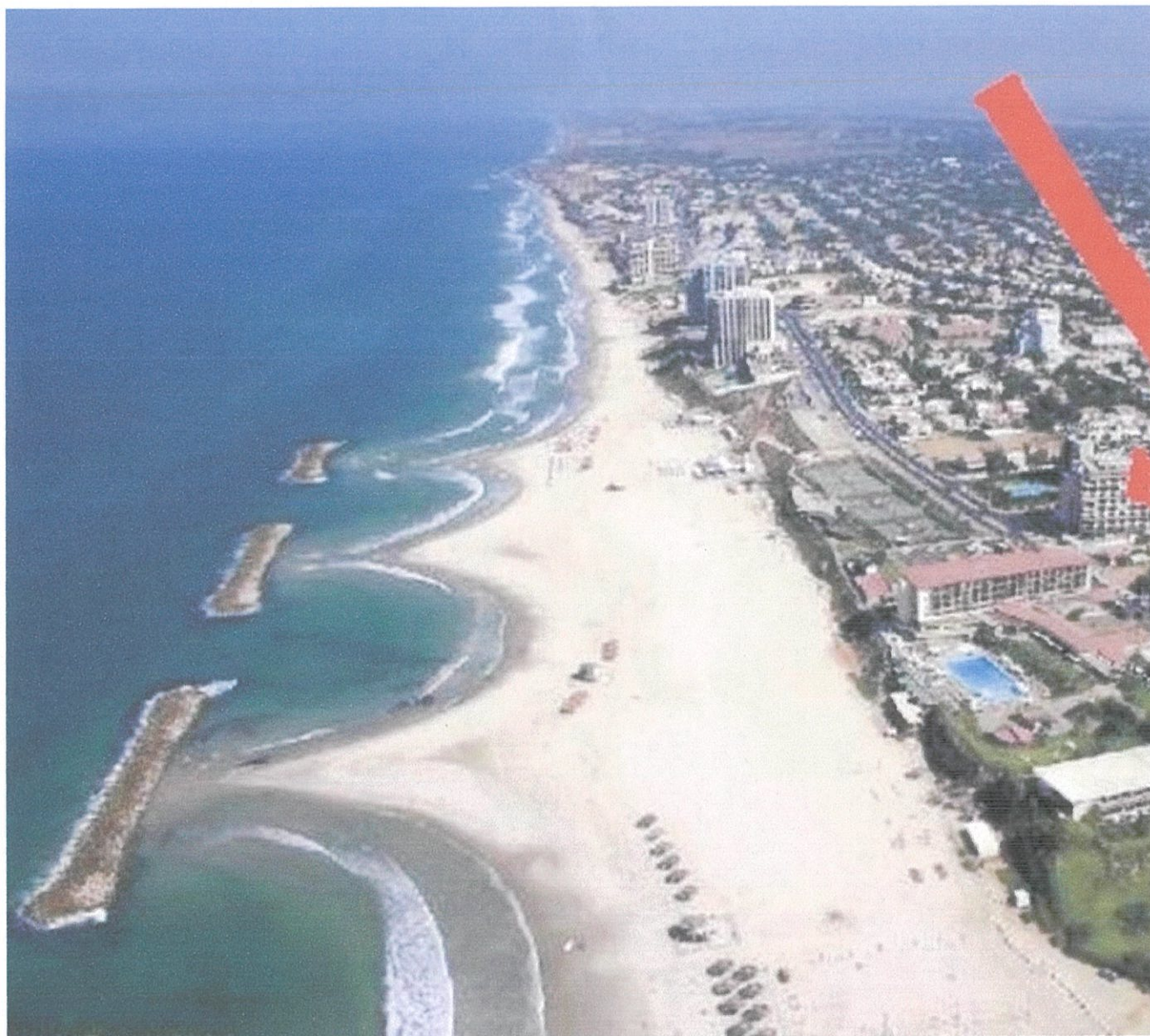


Feedback from the Northern Panel community meeting 29 November 2017

COASTAL UNIT D: WESTSHORE	COMMUNITY FEEDBACK
I am concerned about...	<ol style="list-style-type: none"> 1. Need to act now not in 20 years. Especially southern end of Westshore. Westshore part of recreation for all Napier residents and visitors. 2. Residents bearing the brunt of all the costs. Important asset for Napier that is not being as well maintained for the public as it could be. 3. Southern end of Westshore beach – what is being done there? 4. <u>Costs</u>. To be shared by all just as costs for parks, play areas, and libraries are shared. Not everyone uses them but they have community value. 5. Whakarire Ave wall. Get more quotes/tenders. Build wall without landscaping. 6. Why doesn't the "PORT" be a good neighbour and just bring material from channel to Westshore. 7. Westshore beach coastal erosion plan

Community meeting Wednesday 29th Nov. Westshore surf club

Current action.

- Great to see the community, Council and Port of Napier working together
- Vision of action vs blame is a positive outlook for the future
- Fantastic to see the Albatross dredge completing shipping channel maintenance & dumping sand south towards the surf club.
- Positive response from this action from locals & bystanders. Greta seeing action rather than meetings to discuss & miss opportunities.
- No disruption to the beach. Clean. No noise, open use of the area
- Natural life has not been effected. Sighted dolphin, orca (mother & pup) swim through the dump zone off the surf club after dumping was complete
- Replenishment of the shingle sea wall is positive but not a final solution.

Future action

- Future action must be based upon **replenishment**
- With port extension additional sand (like for like) material must be available for replenishment.
- With ongoing shipping channel maintenance there must be continued (like for like) sand available for replenishment.
- Council must take ownership (government 100 yr plan makes them responsible).
- Port of Napier has operated within council consents so can't be deemed the instigators or have the blame finger pointed at them. The channel could be a causal factor but they were given consent.
- Council must provide consent for the dumping of sand (port maintenance/expansion) south of the current consent zone.
- Dumping and possible "rainbowing" if the dredge has the ability
- Cost?

Council has sand available through port maintenance and expansion. Becomes an issue of consent & relationship. Port has the funding and needs a consent. Apply the appropriate consents.

Rate payers? It is an issue for Hawkes Bay. Westshore residents can't be expected to fund the replenishment of a beach. It is used by everyone in HB. Why pay now? Because government wants action?

Corporate sponsor. Port of Napier has the material. Port of Napier wants consent to dump materials due to maintenance & expansion. Council MUST work with them. They become a corporate sponsor of sorts by supplying the material.

- **Continued action.** There must be continue progress. Even if it is to extend the maintenance dredging

Current action has been unbelievable. Keep up the great effort & foresight
